- 1. Sinopec Pat Heung Petrol Filling Station (Lot No. 2096 in DD111, Kam Tin Road, Pat Heung, Yuen Long);
- 2. Sinopec Shek Kong Petrol Filling Station (Lot No. 811 in DD110, Kam Tin Road, Shek Kong, Yuen Long);






